New Business Profile: Acqua al 2

"A Taste of Italy in the Berkshires"

The new restaurant in downtown West Stockbridge, Acqua al 2, is the latest incarnation of the original concept successfully launched by chef Stefano Innocenti in 1978 in Florence, Italy. The idea was to offer a menu of affordable yet high-quality food featuring dishes from across Italy. The formula was such a success that Acqua al 2 has since opened franchises in San Diego, Washington, DC, Annapolis, and now West Stockbridge.

The owners of our local Acqua al 2 are Valentino and Liza Pagliari. Valentino grew up in his Italian immigrant family's restaurant business in London, then traveled to Florence where he studied architecture and gained experience working in nightclubs and restaurants. The original Acqua al 2 became his favorite place to dine, and he was soon invited to become a partner in the restaurant. His wife, Liza, originally came to Florence to study printmaking, where she met Valentino. After marriage and six years living in Florence, they have now settled in the Berkshires, where Liza's family has had a home for more than 20 years. Liza manages the restaurant in addition to studying to become an art therapist, and her printmaking skills have been put to good use enhancing the decor.

The menu features proven and successful reinterpretations of traditional dishes drawn from various regions of Italy, including antipasti, cheeses, salads, pastas, meats (including steak and chicken), and desserts. Diners are welcome to try full portions of any dishes they choose, but Valentino and Liza suggest the *assaggio*, or tasting option, that offers a sampling of dishes from the different courses. Acqua al 2 currently offers a selection of mostly Tuscan wines, which they hope to expand to include southern Italian, French, American, and also local varieties.

Valentino says he is very happy with the warm welcome they have received from the town and the people of West Stockbridge, and the response has been positive. As we all know, midwinter is a relatively quiet time here in the Berkshires, so perhaps this would be a good time to check out a new dining option here in town!

Located on Center Street in downtown West Stockbridge, Acqua al 2 is open year-round, Wednesday through Sunday, from 5 to 11 pm. The owners plan to open soon for lunch too. Reservations (required for parties of five or more) may be made after 3 pm by calling (413) 232-5025.

Select Board Meeting Minutes

January 21, 2025

The quorum was present remotely: Select Board members Andrew Krouss and Chair Andrew Potter, Kathleen Keresey, and Town Administrator Marie Ryan.

Others Present: Fire Chief Vinny Garolfoli and Stockbridge Town Administrator Mike Canales.

Andy Potter opened the meeting at 6 PM.

Andy Krouss made a motion, seconded by Kathleen, to approve the minutes from August 28, 2024, December 16 & 18, 2024, and January 8 and 13, 2025.

All were in favor, minutes were all approved.

Town Administrator Update:

Marie informed the Board that west Stockbridge has been included in the Emergency Management Service study being completed by the Collins Center in Amherst. This study will include most of the south county towns.

Curt requested bids for the design of the intersection of Main Street, Lenox Road and Swamp Road. The winning bid was from Foresight Land Services.

Marie said that the Congregational Church in Town is having a food drive along with assistance of St. Patrick's Church. This drive will run through February 2nd. Food can be dropped off at the churches or at Town Hall.

<u>Appointment of Police Officer Nicole Miller:</u> Police Chief Marc Portieri

Chief Portieri introduced Nicole Miller and requested that the Board appoint her as a Part-time officer. He hopes that by July, everything is working great and then we can hire her to fill the remaining full-time opening. Nicole is currently a Part-time Police Chief in Washington and has worked as an officer in Becket for 16 years. She is up to date with all her required training and would make a great addition to our Police Department. Marc also stated that she is very involved with community policing and has a lot of experience with writing grants which will be an asset to the Town.

Nicole greeted the Board and said she is very excited to work here. She hopes to put in many hours that will include community policing. She looks forward to working with our Police Department and has worked with Marc in the past in the Town of Becket.

Kathleen made a motion, seconded by Andy Krouss, to appoint Nicole Miller as a Part-time Police Officer.

All were in favor, motion approved.

Shared EMS and Fire Department with Stockbridge: Marie and Stockbridge Town Administrator Mike Canales

Marie explained the purpose of this meeting is to review the financial aspects and set-up of a possible shared EMS and Fire Department with Stockbridge. She said she knows the Board has been supportive of the idea as she and Mike have been gathering information and researched the options. Now is the time that the Board will need to vote to officially determine if this is the direction they want to move. The need for a vote now is due to a two financial items that will need to be on the Annual Town Meeting warrant.

Mike Canales then reviewed the slide presentation. He mentioned that the two financial items that would need to be on the Annual Town Meeting warrant for FY26, if the Board voted to proceed with the shared services, is West Stockbridge's portion of \$180,000 to order a new ambulance and to increase our Fire Chief and Fire Deputy salary line item to \$102,000. He said that the

shared services would allow for 24/7 ambulance coverage as well as increased response times by the Fire Department. Fire Chief Garolfoli also commented that the responders of the ambulance will also be fully trained at the highest level not just basic service. All the newly hired EMTs and Fire Fighters will all be crossed trained to cover both positions.

Mike and Vinny also explained that having the shared services will provide more opportunity for the Town's to apply for grants as a regional EMS and Fire Department. They hope this will help to cover some of the costs as we move forward.

Kathleen made a motion, seconded by Andy Potter, to move forward with a shared EMS and Fire Department with Stockbridge.

All were in favor, motion as approved.

Housatonic Water Company Project approval:

Andy Potter explained to the Board that the Attorney General and the Department of Public Utilities have an agreement with the Housatonic Water Company which includes a requirement for several projects to be completed. Each project requires a vote of approval by all three towns prior to starting the project. Should any one of the three towns vote it down, the agreement cannot continue. Andy stated this is the first projected to be voted which includes the Water Company hooking up to the Great Barrington Fire District water lines in Christian Hill Road. This will protect West Stockbridge should anything happen to the current water lines, we will be able to get water from Great Barrington. This is a back-up system for our residents.

Andy Potter made a motion, seconded by Andy Krouss, to approve the Housatonic Water Company project to hook up to the Great Barrington Fire District water line.

All were in favor, motion approved.

Select Board Speak:

Andy Potter mentioned that he is working with Curt Wilton, Director of Public Works, on a grant application through T-Mobile to assist with a few of the Complete Streets projects.

He is also working with the Library Trustees and the Librarian Rachel on a grant application through AARP which will allow the library to purchase equipment to hold outdoor movie events in the parking lot at Town Hall. This project would include the purchase of a large screen and speakers.

Kathleen made a motion to adjourn, seconded by Andy Krouss.

All were in favor, meeting adjourned at 6:52 PM.

MMRHS Student Jade Abderhalden Interning with West Stockbridge PD

Monument Mountain Regional High School (MMRHS) proudly announces that senior Jade Abderhalden of Great Barrington will be studying criminal justice at Westfield State University, jumping off the springboard provided by her internship with the West Stockbridge Police Department.

Jade says that she's not sure what direction she'll take once she's earned her degree. "I'm open to anything," she said, although right now the jobs of CSI (crime scene investigator), FBI agent, but also EMT (emergency medical technician) sound enticing. In addition to her four afternoons per week internship and a full class load, including "Intro to Health Services," Jade is also now enrolled in a criminal justice course at Berkshire Community College where she's earning free college credits she won't have to pay for at Westfield. In her time at Monument, Jade has played four years on the varsity basketball and softball teams, and she also played two years of volleyball.

Jade's early introduction to the law enforcement field has already won her admirers and perhaps followers. During last fall's Career Day, she stole the show at the Police and Emergency Services Department table, attracting even more attention than Archer, Great Barrington PD's comfort dog. The sophomores in attendance that day were happy to hear from working officers who were 10, 20, or even 30 years older than them. But they were most keen to hear from their classmate who was sitting among them, sharing her path and anecdotes from her time with the West Stockbridge PD.

MMRHS guidance counselor and internship coordinator Sean Flynn explained why he thought Jade would excel at police work. "She has an inner strength coupled with a strong sense of empathy that would make her a good fit to work in so many different professions from law endorsement, protective services, to health care, or in the field of education or social assistance or even in business because she is a competitor and holds herself and others to a high standard."

The West Stockbridge PD is hoping to get Jade a paid summer position that would help further offset the expense of college. She's also applying for several scholarships, including those offered through the Kiwanis Club and funds at the Berkshire Taconic Community Foundation.

Even as recently as September, though, Jade's path was not nearly so clear. "I had no clue what I wanted to do," she acknowledges now. As a young girl she had her heart set on "doing nails," although a hint of her future path might have been guessed at through her favorite TV show, *Law & Order*, as well as the attention she paid to the police scanner. "I'm a nosy person. I want to know what's going on."

The shift in the goal from esthetician to policing was brought about in large part thanks to the example set by Jade's late stepfather, Jason Hall, after he took the state trooper's test and scored 99. He did not end up with a career in law enforcement, however, because he was then called into duty to manage John's Garage, the family business in Housatonic. Hall died of cancer in early 2023 at just age 44, and Jade wants to take up the path where he left it off. "I kind of feel like I am filling his spot in going to do this in his place."

No matter which career path Jade ultimately chooses, she wants to be of service, to repay the debt she believes she owes her community. "So many people helped get me to where I am today through school and sports, and most of all when my stepdad was sick. My end goal is to give back in any way possible, whether that's through the police department or the health-care field. This community helped raise me—I just want to be in a field where I can help someone."

The Grant will cover the cost of all the units plus the labor. Also, the buildings attic insulation will be upgraded as part of the Grant.

Plants & Gardens;

The December Local Yokel "Santa's Wish List" generated some great donations towards the Plants and Gardens Fund and will help Lisa Parker with her wonderful beautification she performs throughout Town. \$1,825.00 has been donated for these efforts. These funds are earmarked for materials only but not labor. Lisa's efforts do not go unnoticed and this type of generosity really shows and is much appreciated. Thank You Lisa.

Municipal Small Bridge Program (Willson Road);

The MassDOT Municipal Small Bridge Program funds Cities and Town who have bridges with a span greater than 10' but less than 20'. I have just been informed recently that the Willson Road Culverts do in fact meet these "Bridge Span" requirements, therefore this type of structure qualifies for the Program. This is exciting news for the Town because this structure is failing and prone to frequent flooding. I have been working on getting this crossing replaced for many years now, through funding sources that include H.V.A. / M.V.P and our Hazardous Mitigation Plan. As of today, we have not had any luck securing any funding these Grant Programs. Having another Funding source may just give us the boost we need. I have put together an application and have met the deadline for submission. The Application is for Phase1 (Design and Permitting). If awarded we can secure \$100,000 in funding and utilize the Bridge Engineers from MassDOT to complete these tasks. Once we have the design and permitting complete we can then apply for the Phase 2 portion and if awarded, we could receive \$500,000 for the Construction of a new bridge.

Town Hall;

During the next few weeks of the FY26 Budget talks there will be discussions on some failing components within the Town Hall Building.

BOILERS

During this year's yearly inspection, it was discovered that one of the units had developed a leak in one of the sections. Due to this discovery the Town has been put on notice to repair or replace to correct the deficiency. I am in the process of obtaining estimates

from Commercial Contractors to help provide budget figures. Keep in mind these boilers are the same age in years and running hours. First installed and funded by the Berkshire Hills Regional School District in 2024, they both have 20-years of service. I am gathering and exploring other heating options to see if there is a cost-effective replacement heat source with a return on investment that would make better fiscal sense.

FIRE PROTECTION SPRINKLER SYSTEM:

The system goes through a yearly inspection and is also subject to out dated life expectancy regulations. This year our system was subject to compliant upgrades. There were numerous deficiencies reported along with a proposal for corrections. These corrective actions would cost \$14,994.91.

Select Board Speak:

Andy Potter mentioned that the School Committee will be holding meetings in regard tot eh School District Budget on February 13th and 21st. He stated this will be a tight budget year and encouraged residents to attend these budget meetings.

Andy Potter made a motion, seconded by Kathleen, to enter into executive session and not return into Open Session.

• Anticipated executive session in accordance with M.G.L. c. 30A Paragraph 21 (a)(3), to discuss strategy with respect to collective bargaining, as meeting in open session would have a detrimental impact on the Board's negotiating position (Director of Public Works Contract renewal)

Alternatively, you can scan the QR code provided here. This information will be shared with your local legislator. Keep this information handy as the weather changes and mud season begins. As we know, the increased challenges brought on by climate change are mounting. In Berkshire County, gravel road impacts include increased erosion, washouts, and more and more MUD. Despite these difficulties, these dirt roads are part of the character of our communities. If the legislation recently proposed by Governor Maura Healey passes, additional Chapter 90 funding for road infrastructure to our Berkshire towns will be increased. In an

effort to "stabilize and enhance our state's transportation infrastructure," Healey's proposed bill increases support for small and rural communities that need extra help with local road projects. If the bill is passed, that money would come in a more reliable manner over the course of five years. (Check out this link for more information: https://malegislature.gov/Bills/194/HD4323.)

This information gathering around dirt road problems is just a small part of a year-long MVP Regional Unpaved Roads Project. All three

western Massachusetts regional planning agencies—Berkshire Regional Planning Commission, Franklin Regional Council of Governments, and Pioneer Valley Planning Commission—have partnered to update this existing Unpaved Roads Stormwater Toolkit: https://frcog.org/publications/unpaved-roads-stormwater-management-toolkit. The goal of the toolkit is to provide highway departments with a methodology for identifying recommended solutions for key unpaved road segments, as well as the necessary designs to implement solutions that will improve these roads over the long term.



March History Quiz Question:

From the post-Civil War era up to the early 1900s, James S. Moore was one of the more important citizens in West Stockbridge. He served in various positions in town government, owned and sold real estate, formed the Water Company, and was a director of the Miner's Savings Bank. He was probably the most well-known resident at the time.

James was also the local druggist and likely the person in town with the most medical knowledge. People went to him for advice. As a prominent civic leader, he likely received requests and communications from all over the area. One appeal for services that we came across was most unusual, not only for the time but would even raise questions now. What would that be, and how did James handle it?



History Quiz Answer:

In the 1890s, the Berkshire Evening Eagle published daily national and Pittsfield news. In addition, on Thursdays, it had a page or two of social notes from many of the towns in the county. Each town would contribute descriptions of social events and news of residents, items like who had visiting relatives, where someone might have gone for vacation, a birthday party, or just local gossip. One of our favorites was this report: "Last Monday night, Dr. Arnold commenced his annual coon hunt and secured three." This column is a fun read and an intriguing look into social life in that era. (It was not much different than a visit to the transfer station, post office, or Public Market now.)

The body of D. J. Spencer, who some years ago resided in this vicinity, arrived here Monday fron Fort Smith, Arkansas, addressed t) J. S. Moore our druggist. Mr. Moore had received a letter from the dead man's wife, requesting him to take charge of the body and have it interred in the West Stockbridge cometery. Upon his demand for the remains, he found an express bill of \$85 which must be paid before it would be delivered over to him, and as nothing had been said by the wife in regard to money matters and Mr. Moore not know ing the circumstances of the parties, he naturally refused to take the risk. He telegraphed to Fort Smith for further instructions, but up to Tuesday noon had heard nothing, and the body is still in the keeping of the Express company.

In the issue of Thursday, July 9, 1891, there was a unique paragraph about a request made to James Moore, our local pharmacist, reprinted here.


Clearly, James Moore received the body by surprise. There is no record of what he finally did to resolve the "package" left at the Railway Express office or if he received the \$85 from the widow. We do know that D.J. Spencer was born in West Stockbridge in 1827 and died of cholera in Fort Smith, Arkansas, in 1891. The situation must have been resolved because he was eventually buried in the Stockbridge Cemetery.


